SAC Is Back....Well, Sort of

The Air Force Global Strike Command, (AFGSC) was activated on August 7, 2009. On February 1, 2010, the command assumed the U.S. Air Force's strategic long-range nuclear-capable B-2 Spirit and B-52 Stratofortress bomber missions. With the assumption of the 8th Air Force mission, the command gained three bomb wings: the 509th at Whiteman AFB, Mo., the 5th Bomb Wing at Minot AFB, N.D., and the 2nd Bomb Wing at Barksdale AFB, La. These units were previously part of Air Combat Command. The AFGSC is a major

command headquartered at Barksdale. AFGSC is also responsible for the Nation's three intercontinental ballistic missile wings.

Special Extra Earnings for Military Service

Please share this with anyone who had active duty service between January 1, 1957 and December 31, 2001 and are planning for retirement.

In a nutshell it boils down to this: You qualify for a higher social security payment because of your military service, for active duty any time from 1957 through 2001 (the program was done away with on 1 January 2002). Up to \$1200 per year of earnings credit can be credited at time of application - which can make a substantial difference in social security monthly payments upon your retirement. You must bring your DD-214 to the Social Security Office and you must ask for this benefit to receive it!

This is something to put in your files for when you apply for Social Security down the road. It is NOT just for retirees, BUT anyone who has served on active duty between January 1957 and December 31, 2001.

Again, this benefit is not automatic, you must ask for it! We've all been on active duty between 1957 and 2001 or know someone who has. This may be too early for some of you to think about Social Security but, keep living and you will get there.

Since 1957, if you had military service earnings for active duty (including active duty for training), you paid Social Security taxes on those earnings. Since 1988, inactive duty service in the Armed

Forces reserves (such as weekend drills) has also been covered by Social Security.

Under certain circumstances, special extra earnings for your military service from 1957 through 2001 can be credited to your record for Social Security purposes. These extra earnings credits may help you qualify for Social Security or increase the amount of your Social Security benefit.

Special extra earnings credits are granted for periods of active duty or active duty for training. Special extra earnings credits are not granted for inactive duty training.

If active military service occurred:

- From 1957 through 1967, they will add the extra credits to your record when you apply for Social Security benefits.
- From 1968 through 2001, you do not need to do anything to receive these extra credits. The credits were automatically added to your record.
- After 2001, there are no special extra earnings credits for military service.

How You Get Credit For Special Extra Earnings: The information that follows applies only to active duty military service earnings from 1957 through 2001. Here's how the special extra earnings are credited on your record:

- Service in 1957 Through 1977: You are credited with \$300 in additional earnings for each calendar quarter in which you received active duty basic pay.

- Service in 1978 through 2001: For every \$300 in active duty basic pay, you are credited with an additional \$100 in earnings up to a maximum of \$1,200 a year.

If you enlisted after September 7, 1980, and didn't complete at least 24 months of active duty or your full tour, you may not be able to receive the additional earnings. Check with Social Security for details.

DD-214 and Veteran Records

It's official; DD-214's are NOW Online. The National Personnel Records Center (NPRC) has provided the following website for veterans to gain access to their DD-214's online at:
www.archives.gov/veterans/evetrecs/index.html

This may be particularly helpful when a veteran needs a copy of his DD-214 for employment purposes. NPRC is working to make it easier for veterans with computers and Internet access to obtain copies of documents from their military files. Military veterans and the next of kin of deceased former military members may now use a new online military personnel records system to request documents. Other individuals with a need for documents must still complete the Standard Form 180, which can be downloaded from the online web site. Because the requester will be asked to supply all information essential for NPRC to process the request, delays that normally occur when NPRC has to ask veterans for additional information will be minimized. The new web-based application was designed to provide better service on these requests by eliminating the records centers mailroom and processing time.

DFAS to Resume VSI/SSB Recoupment

*(Defense Finance and Accounting
Service (DFAS) News Release)*

Recoupment of military retirees' Voluntary Separation Incentive (VSI), Special Separation Benefit (SSB) and other separation payments by the

Defense Finance and Accounting Service will resume in August 2010.

VSI, SSB and certain other separation payments, such as severance pay, were offered to active duty military members in an effort to reduce manpower in certain career fields, primarily during the 1990s. Because federal law prohibits military members from receiving both separation and retirement payments for the same period of service, provisions of these programs included repayment should an individual join the Ready Reserve or return to active duty and earn status as a military retiree.

On June 1, 2009, in response to retirees' concerns, DFAS temporarily stopped deducting these repayments from retirement pay while the DoD conducted a formal review of the recoupment program. Prior to the review, the federal statutes governing these programs did not allow the Department of Defense or DFAS to alter repayment rates or provide alternative repayment plans regardless of the financial hardships a retiree may be experiencing.

The DoD review is complete, and Congress has amended Sections 1174(h) and 1175(e) of Title 10, United States Code, to help limit the financial strain on military retirees as they repay their outstanding balances. The new statutes allow DFAS more flexibility to accommodate for financial hardship and modify payment plans. As a result, DFAS has reduced the maximum recoupment rate from 90 percent to 40 percent. DFAS also will consider more lenient repayment plans for retirees who are experiencing financial hardship.

Affected retirees will receive notification letters at least 90 days before recoupment's resume. If they feel the rate of recoupment will create a financial hardship, they may request a more lenient repayment plan by providing financial information on the Financial Statement of Debtor form enclosed with the notification letter.

This monthly recoupment may also affect former spouses who receive Uniformed Services Former Spouse Protection Act payments from such retirees. Former spouses affected by this recoupment also will receive a notification letter prior to the resumption of recoupments.

Employment Opportunities

CMSgt (Retired) Jim Rooney provides the following from Greg Hurd:

"Jim, sorry got tied up with interviews and just needed to take a break.

I am VP for Saudi Operations for a company called Parts and Repair Technical Services, PARTS Inc. We have two contracts in Saudi Arabia at the current time; both are for training the RSAF on a go/no-go basis. We think we provide a pretty comprehensive package, not like the old days of six figure salaries but when you include the salaries, benefits, etc. we are well into the six figures.

We offer housing, a 4000 sq ft villa for each person/family, vehicle to be shared

with one other person, a base salary with a 15% Int'l premium provided every other week, medical insurance, life insurance, a 401K, 0-5% bonus at the end of the year that is included in the following years salary as a raise, the cost of a round trip airfare to Home of Record for the member and/or family if they accompany (we encourage wives and kids to come and will pay for them--kids up to 18 yrs old. We pay for their trips and k-12 schooling at the Int'l school), provide 15 days of pd vacation per year, plus 3 US holidays off, plus two 5 day vacations during the Saudi Holidays of Ramadan/Hadj, plus 5 sick days per year, we take care of the passports, visas and pay for/reimburse for physicals, ship 600# of HHLgds over at the end of the 90 day probation period, internet connectivity at the villa and a few other things. It is really a pretty good package all in all. Pay is pretty good, with the base starting at the low 50's. As long as you are 'domiciled' outside the US for 330 of 360 days (doesn't mean cannot come home on vacation, etc.) up to \$87,500 is tax free. Now having given that as the basic package we are looking for the following:

F-15 AR, ECS, Electrical, Structures, Machinists, Pneudraulics, Phase, Weapons, Munitions, and Egress. Obviously we prefer folks that have experience in the AOR, working with the Saudi's, training experience are important to us but we can work with folks depending on their experience, etc.

Please forward this to as many folks as possible. Our contract has been awarded and we are waiting on the funding to proceed. All that should be happening shortly so we are looking to

deploy folks around 10 June, give or take a little.

New AF Dining Program Opens Doors for Retirees

Thanks to the Air Force's Food Transformation Initiative (FTI), retirees at six bases will soon be able to use military food service establishments previously reserved for active-duty Airmen.

Retirees will pay the same market price as everyone else, and there will not be an added surcharge on top of the menu price. The six Air Force bases participating in the initiative are Elmendorf AFB, Alaska, Patrick AFB, Fla., MacDill AFB, Fla., Fairchild AFB, Wash., Little Rock AFB, Ark., and Travis AFB, Calif.

This pilot program not only opens food establishments to all members of the base community, but customers will also see changes to food and beverage options, resulting in greater quality and variety, said Air Force Services Agency officials.

TRICARE Affirmation Act

The Tricare Affirmation Act, aimed at protecting people in the military health care program from being penalized for not having private insurance, was signed into law April 26, 2010 by the President.

The new law provides a specific exemption for Tricare beneficiaries and for nonappropriated-fund civilian employees of the Defense Department from a requirement of the Patient Protection and Affordable Care Act that will require people without minimal health cover to either buy private insurance or face a \$750 penalty.

Tricare health insurance is specifically defined by the law as minimal essential coverage, which provides an exemption from the penalty.

Space-A Travel

SCOTT AIR FORCE BASE, Ill. (AFRNS) Retirees who dream of climbing an Egyptian pyramid, schussing down a black diamond ski slope in Bavaria, or walking on a Hawaiian beach can make these dreams come true with space-available travel.

Typically, these dreams require a lot of money; however, Space-A travel is free with the exception of customs or federal inspection fees on some chartered commercial air service missions.

Air Mobility Command aircraft fly all over the globe and often have open passenger seats available. An AMC aircraft takes off every 90 seconds. More than 130,000 Space-A travelers take advantage of this military benefit each year.

Retired Airmen with a retiree ID card and who are eligible to receive retired or retainer pay, fly as Category VI passengers. Since missions can be rerouted, delayed or cancelled for a variety of reasons -- weather, maintenance issues or higher priority missions -- retirees need to be flexible. They need to plan for any potential delays and added expenses for stays, especially in high-cost areas.

There are four different methods for signing up for Space-A travel: in person at the passenger terminal or remotely via telephone, fax or e-mail. Sponsors must provide their name and information on all traveling dependents, and their desired destination(s).

Retirees can also use the DOD-chartered airlift missions for Space-A travel, if seats are available. Although

retirees cannot visit their grandchildren in Iraq or Afghanistan, they can travel to Germany if the aircraft transitions there.

If traveling overseas, retirees should know the restrictions of the host country. For example, retirees traveling to Germany are not authorized to purchase items in the Base Exchange, but they can go off base and shop in the local community. Status of Forces Agreements restrictions, U.S. State Department Travel Advisory guidelines, the Foreign Clearance Guide and passport and visa requirements are all necessary items to research.
