I Was There

Capturing our history with humorous stories about a first in the career field, or anything of interest involving the Personal Equipment, Survival Equipment, Aircrew Life Support, or the Aircrew Flight Equipment career fields).

"In July 1974 I was assigned to the 52nd Tac Fighter Wing, NCOIC of the Life Support Shop, 23rd Tactical Fighter Squadron (F-4 aircraft), Spangdahlem AB, Germany.

After processing in one of my NCOs took me to supply to pick up L-2B and MA-1 Flight Jackets. I asked how we were authorized to wear the jackets and no one had any idea. It's always been that way, so goes the response. It was standard practice that all Life Support Personnel in the two F-4 Fighter Squadrons on base all had flight jackets with squadron patches and name tags identical to those worn by the aircrews.

In late March of 1975, a new Wing Commander was assigned. (Withholding his name) One of his first visits was to the 23rd for a new parachute harness and have his helmet & mask inspected.

He immediately introduced himself to me as the new Wing Commander and wanted to know why I was wearing a flight jacket. What authority allowed me to do so. I did not have a good answer, so he ordered me and all Life Support people on the base to turn them in to supply.

I told my guys to just store them at home. It was still cold in April, so we were wearing our

Field Jackets. While sitting in the office I had an idea. I told one of my NCO's to go with me to pull a survival kit. He thought that I should be reading the checklist while he took the survival kit out. But I insisted I should do it. As I sat in the ejection seat checking the safety pins etc., I was somehow able to move my arm around so that the jacket wrist strap got caught on some part of the seat. (for the life of me I cannot remember what it was) But, it was enough for me to tell my young NCO to take notice of it as a witness. On 11 April 1975 I wrote up a hazard report (#HEP75-19-DO-09) on the field jacket and at the same time I made a suggestion to replace the field jacket with unused flight jackets while working in the ejection seat. (I was not smart enough to keep copies)

In July of 1976 the safety Office at Norton AFB sent a msg. to CINCUSAFE Ramstein and WR ALC Robins AFB GA. The short version, bottom line reads: Concurred with above recommendation and Jacket L-2B has been included in TA 016A to issue 1 per 922X0 for use in and around ejection seat aircraft. The MA-1 flight jacket was also added to that recommendation.

We all know that USAF does not move very fast. On 10 Aug 1976 USAF sent a letter to: 52 TFW/SE. Subject: Hazard Elimination Program Item 75-19-DO-09, 52 TFW Hazard Report 75-W-01, Clothing for Life Support Technicians. Basically, repeating the msg. noted above.

Please thank the originator for taking an active part in the USAFE Hazard Elimination Program.

On 23 Aug 1976 the 52nd TFW Commander sent a letter to the 23rdTFS/CC and 23TFS Life Support.

"I extend my personal appreciation for your initiative in identifying this problem area and your active support for our Hazard Elimination Program."

I know he was not happy having to write that very short letter. I told my guys to start wearing their newly authorized flight jackets.

The Wing Commander continued to fly with us and never once said anything about us wearing the flight jackets nor to me personally. I do have copies of the last three documents mentioned.”

Thanks for the input, Frank! Hopefully this will inspire others to send in their stories.

I am honored to be asked to contribute to the 'Aircrew Life Support, Aircrew Flight Equipment, Veterans and Retirees Newsletter' as my last parting shot after 30 years in our great Air Force. A special thank you to Steve Wyatt for reaching out. I first met Steve when he was the Wing Life Support Trainer at the 57th Fighter Weapons Wing at Nellis in 1990. He was a TSgt and I an Airman Basic and as you all know, Steve is the definition of a professional and was a huge influence throughout my career.

Thanks to Steve's influence early on, I have been blessed with a great career that I can break up into three distinct periods. The first 10 years as a Life Supporter was with HH-60's at Nellis, F-16's at Kunsan, F-15E's at Seymour Johnson and F-16's at Nellis again. The second 10 years were all special duties as USAF Thunderbirds Life Support, Military Training NCO at Air Force Academy and a First Sergeant at Andrews. The last 10 years have been AFE with Rescue at Moody, F16's and F-35's at Hill and AC-130 U/J, MC-130 U/J, CV-22's and U-28's at Hurlburt Field. It has truly been a great and varied ride and I am grateful to have been a part of it all.

Steve asked me to comment on the career field changes I've seen since I enlisted until now, and my thoughts on the merger. The overarching mission from Life Support to AFE to provide safe and reliable life-saving

equipment to the aircrew, of course has not changed over the years. As a field level Chief, I can attest that the men and women in AFE are working hard to ensure the career field is performing at higher levels than ever before.

From my perspective I think us old guys are embracing technological advances more readily these days and it seems to arrive in much more rapid succession than just 10 years ago. The younger Airmen enlisting today are way more adept with technology than I ever was. I believe they will continue to usher in new ideas that may seem far-fetched now but may be the solution to decade's old problems. We need to feed their curiosity and allow them to take the career field to higher levels for the future.
