Survivor Benefit Plan Benefits

A new law will prevent military retirees from losing Survivor Benefit Plan benefits when their ex-spouse dies before they do, by allowing the benefit to be transferred to a current or future spouse. The National Defense Authorization Act for fiscal 2015 gives retirees the option of now having Survivor Benefit Plan annuity payments go directly into a special-needs trust for a disabled child. This special-needs trust statute does not apply to disabled spouses.

"This new option is the result of an amendment to the public law covering SBP, and is a welcome change for parents of disabled dependent children," said Tammy Hern, the Air Force's SBP program manager.

Retirees who have SBP coverage for a disabled dependent child may now – or at any time -- have a special-needs trust created and elect to direct SBP annuity payments to the trust. This irrevocable decision may be made during the life of the retiree through a written statement that designates future SBP payments go into the special-needs trust. In situations where SBP payments are made to more than one dependent child, the special-needs trust will be treated as a dependent child for the purposes of determining the shares payable to each child.

To irrevocably add a special-needs trust to existing child SBP coverage, retirees must submit a written statement requesting the annuity be paid to a trust. The statement must include the name and tax identification number of the trust. Additionally, the retiree must submit a certified letter from an actively licensed attorney verifying that the trust is a special-needs trust created for the benefit of the disabled dependent child. Examples of both statements can be found at www.retirees.af.mil/sbp/.

"It is vital that people wanting to create a special-needs trust exercise due diligence and consult with an attorney well-versed in this specialized and complex area of law," said Hern.

The SBP statute requires that a special-needs trust for a dependent disabled child also meet federal statutory requirements, and once the trust is created, it is irrevocable.

If officials determine the special-needs trust is invalid or otherwise faulty, then SBP annuity payments will revert back to being made directly to the dependent child. If this occurs, the dependent child's entitlement to other benefits such as Supplemental Security Income and Medicaid may be affected.

A special needs trust election can be added to child SBP coverage even after the retiree dies.

"When the retiree dies, if SBP child coverage has been elected and the child is disabled, the dependent child's legal parent, grandparent or court-appointed legal guardian may irrevocably elect to have the SBP annuity payments made to a special-needs trust," said Hern.

TRICARE Pharmacy Benefits

Several changes to the TRICARE pharmacy benefit took effect on February 1, 2016. First, copays for drugs filled at retail pharmacies and TRICARE Pharmacy Home Delivery increase slightly. Second, TRICARE Over-the-Counter (OTC) drug coverage becomes a full and permanent part of the TRICARE benefit, requiring that beneficiaries pay the usual generic copays. Congress Passes Law Creating ID Card for Veterans

In July 2015, the Veterans Identification Card Act was signed into law creating a government issued Veterans ID card, something many veterans have been requesting for years.

The military only issues ID cards for current service members, retirees, and certain veterans with a 100% disability rating. The only option many veterans have to prove their service is a VA ID card used for health care (if eligible), or a state-issued driver's license with a Veterans Designation (but not all states currently offer this).

Many veterans who were not eligible for the above ID cards had a difficult time proving their military service, and often carried a DD Form 214, which contains personal information that should be kept secure (such as the veteran's SSN, birthday, etc.).

The new ID cards will only be valid for proving military service. The new cards cannot be used for benefits through the VA, to access military installations, or to receive other military or veteran's benefits. However, those who are currently eligible for benefits through the military or VA will continue to have them through their current methods.

Update – May 2016: The VA has announced they are still working on the implementation plan for issuing these Veterans ID cards. The VA has the option for charging veterans to help cover the administrative costs of issuing the ID cards. At the time of this update, the VA has mentioned the cards may not be available for issue until sometime in 2017. We will be sure to update this article again when we have concrete information regarding the release date and any associated costs.

All veterans, retired, active duty, Guard, Reserve, and civilian personnel who worked or are working in the USAF Personal Equipment, Survival Equipment, Aircrew Life Support, and Aircrew Flight Equipment career fields are invited to attend. Room rates are subject to Clark County room tax, which is currently twelve percent (12%) and is subject to change. Additional persons in the room over two (2) will be at twenty-dollars (\$20) per person, per night, plus tax. Children twelve (12) and under may share the same room with parents at no additional charge. The hotel will waive the \$24 resort fee per night for the group

Each individual is required to provide a major credit card or cash deposit for first night’s room plus tax, which will be charged in order to guarantee accommodations. Cancellation of hotel room without penalty must occur at least 72 hours prior to scheduled arrival. Penalty charge in the amount equal to first night room and tax will apply to cancellations received inside seventy-two (72) hours. Reservation requests received after the August 26, 2016, noon cutoff will be confirmed on a space available basis at the prevailing rate.

The hotel requires first night room and tax deposit by major credit card at the time the reservation is made. The remaining room and tax will be due at check in. A major credit card or cash deposit will be required to guarantee incidental charges upon check in

TRANSPORTATION TO/FROM THE AIRPORT-LAS VEGAS SHUTTLES: Bell and Showtime are just a few of the companies that offer shuttle buses between the airport and the various Strip and downtown hotels. These buses usually cost around \$7 per person to Strip hotels and under \$10 per person to downtown hotels which makes them a lot cheaper than taxis. You can take care of your return trip to the airport by buying a round-trip shuttle bus ticket which offers some savings. They typically cost around \$13 for Strip hotels and \$17 for downtown hotels.

Whichever shuttle service you use, be sure to ask the driver for a telephone number to call for a pick-up when you have to return to the airport. When you are ready to call for a pick-up, you can often just pick up a hotel house phone and ask them to connect you to the shuttle bus company. Be sure to call at least two hours before the time you want to arrive at the airport. Some shuttle bus companies want you to call 24 hours ahead of time. Ask your driver how far ahead you should call for a pick-up. What you get in savings you give up in time. These buses will typically wait for the bus to fill before leaving which means it can take an up to an hour to get to your hotel. If you're more interested in saving time than saving money, take a taxi. Taxi rides generally average \$15 to Strip hotels and \$23 downtown (not including the tip).
